A statutory audit is legally required when a company exceeds two of these three over successive years:

£15m

Turnover

£7.5m

Total assets

50+

Employees (avg.)

These limits apply to groups as a whole, so an individual company can still require an audit if its group breaches the thresholds, even if the company itself doesn't.

And it's not just about the thresholds. An audit is often required even when limits aren't breached, for example:

- Lenders seeking extra assurance before committing funds
- Overseas parent companies requiring a UK audit for group consolidation
- Investors and business angels wanting comfort their capital is well spent
- Shareholder agreements, grant funders, or regulators mandating an audit
